REGULATIONS FOR BACHELOR OF BUSINESS ADMINISTRATION (HONOURS) DEGREE IN POLICE AND SECURITY STUDIES (BBA.PSS) - (4 YEAR PROGRAMME)

1. Preamble

- 1.1 These regulations should be read in conjunction with the General Academic Regulations for the Undergraduate Degrees, hereinafter referred to as General Regulations, which have precedence over these regulations.
- 1.2 The degree will be awarded to candidates who have successfully completed the programme and passed the examinations in accordance with the regulations set out below.

2. Aims

2.1 This programme offers study on contemporary policing issues. Apart from being introduced to the legal dimensions of the subjects of Policing and Security, students are also introduced to key administration / and organisational issues at operational and management levels. Students are encouraged to develop analytical abilities in security risk assessment and investigative techniques and at the same time building the skills to collect and analyse information on crime and security issues. The programme also aims to impart theoretical and practical knowledge on underlying causes of criminal behavior, as well as various crime control methods.

3. Learning Outcomes

3.1 The programme provides training and development opportunities to working students through first class teaching, industrial attachment; encouraging and facilitating a sustainable balance between personal and career development; teamwork in the work-place, and or, entrepreneurialism.

The forward-thinking approach in curriculum and teaching methods prepare students to continue into postgraduate programmes in the wider areas of Policing, Security Risk Management, Criminology & Forensic Science, and Crime and Criminal Justice, Accounting and Audit.

5. Entry Requirements.

- 2.1 To qualify for normal entry into the Bachelor of Science (Honors) Degree in Police and Security Studies at Bindura University of Science Education, prospective students, in addition to satisfying the minimum conditions prescribed under the General Regulations, must satisfy the entry requirements detailed below.
- 3 Entry Requirements
- 3.1 Have obtained at least five 'O' Level subjects including English Language and Mathematics passed with a Grade C or better.
- 3.2 Have obtained at least two 'A' Level subjects from the following:

Literature in English, Economics, Mathematics, Accounting, Computer Studies, Business Studies, Management of Business or any other relevant subjects

3.3 Holders of a Diploma in Police and Security Studies or equivalent will be considered for admission through mature or special entry.

7. Assessment / Scheme of Examinations

Each course shall be normally assessed through a two or three-hour paper at the end of the appropriate semester.

Assessment of industrial attachment shall be as follows:

Student written reports/assignments 30% Mentor's assessment 50% University Supervisor's Assessment 20%

During Industrial Attachment I, students shall normally be attached to their organisation for a period of at least eight (8) weeks.

During Industrial attachment II, students shall normally be attached to a different organization for a period of at least eight (8) weeks.

The project shall be submitted not later than sixty (60) days before the end of the final year.

8. Determination of Results

A candidate who fails to attain a minimum score of 40% in coursework will not be allowed to write the examination for that course.

For each course and student, the Departmental Panel of Examiners shall determine a final mark and whether that student has passed that course.

The Departmental Panel shall submit, for each course and for each student enrolled in that course, the final mark and the result to the University Board of Examiners.

9. Awarding and Classification of the Degree

To be eligible for the award of the Bachelor of Science (Honors) Degree in Police and Security Studies, a student must have:

Accumulated a minimum of 264 credits

And

Passed all core courses in that programme.

The degree shall be classified using results of **ten** courses, including all the core courses, in each Part that give the student the highest score. The weighting shall be as follows:

Part 1	=	10%
Part II	=	30%
Part III	=	20%
Part IV	=	40%

10. Publication of Results

Results shall be published in accordance with the provisions of the General Regulations.

11. Syllabuses

Detailed syllabuses for the Bachelor of Business Administration (Honors) degree In Police And Security Studies have been lodged with the Senior Assistant Registrar in the Faculty of Commerce.
